## DESCRIPTION OF CITY BOARDS

**Beautification Board:** Plans, conducts, and promotes beautification projects within the City.

**Membership:** 5 primary members and 2 alternates, 3-year terms  
**Meetings:** 1<sup>st</sup> Friday @ 9:00 AM in Council Chamber

**Board of Adjustment:** Grants variances, and decides appeals from Building Official's decisions, regarding land development regulations (City Code Chapter 30).

**Membership:** 5 primary members and 2 alternates, 3-year terms  
**Meetings:** As needed, 1<sup>st</sup> Monday @ 7:00 PM in Council Chamber

**Community Redevelopment Agency (CRA) Advisory Board:** Advises the Community Redevelopment Agency on implementation of the Community Redevelopment Plan and Plan amendments.

**Membership:** 7 primary members and 2 alternates, 3-year terms  
**Meetings:** 3<sup>rd</sup> Thursday @ 7:00 PM in Council Chamber

**Library Board:** Advises and assists Library staff on programs, services, and issues affecting the SB Public Library.

**Membership:** 7 primaries members (2 may be non-Satellite-Beach residents) and 2 alternates (1 may be a non-Satellite-Beach resident), 3-year terms  
**Meetings:** Bi-monthly on 2<sup>nd</sup> Tuesday in January, March, May, July, September, & November @ 6:00 PM in Satellite Beach Public Library Community Room

**Pension Plan Board of Trustees, Firefighters & Police:** Administers the City's pension plan for firefighters & police.

**\*Membership:** 5 members (trustees), 3-year terms: 1 police officer and 1 firefighter elected by their Pension Plan members, 2 City residents appointed by City Council, and 1 member elected by the other four board members and then ministerially appointed by Council  
**Meetings:** Immediately following the General Employees Pension Plan Board of Trustees meeting in Council Chamber  
*\*Appointed members may serve simultaneously on both boards.*

**Pension Plan Board of Trustees, General Employees:** Administers the City's pension plan for General Employees.

**\*Membership:** 5 members (trustees), 3-year terms: 2 employee members of the pension plan elected by members of their pension plan, and 3 City residents appointed by City Council  
**Meetings:** At least quarterly on 4<sup>th</sup> Thursday of February, May, August, and November @ 2:00 PM in Council Chamber  
*\*Appointed members may serve simultaneously on both boards.*

**Planning Advisory Board:** Serves as the Local Planning Agency and advises the City Council on the City's Comprehensive Plan and Plan Amendments.

**Membership:** 5 primary members and 2 alternates, 3-year terms  
**Meetings:** As needed, 3<sup>rd</sup> Monday @ 7:00 PM in Council Chamber

**Recreation Board:** Recommends, assists as needed, and promotes recreation programs within the City.

**Membership:** 7 primary members and 2 alternates, 3-year terms  
**Meetings:** 2<sup>nd</sup> Tuesday @ 6:15 PM in Council Chamber

**Samsons Island Working Board:** Plans, develops, and maintains Samsons Island Nature Park as a nature preserve, passive-recreation park, and environmental-education showcase.

**Membership:** 7 primary members and 2 alternates, 3-year terms  
**Meetings:** 3<sup>rd</sup> Tuesday @ 6:00 PM in Council Chamber

**Sustainability Board:** Makes recommendations on a local action plan for climate change and environmental sustainability initiatives.

**Membership:** 7 primary members and 2 alternates, 3-year terms. 1 non-voting liaison appointed to share expertise in environmental matters.  
**Meetings:** 4<sup>th</sup> Wednesday @ 7:00 PM in Council Chamber
