

Tuition & Fees

This full amount, as shown below, is due at registration or the parent can choose to make 10 monthly payments due on the 1st of each month. Any payments received after the 10th of the month will incur a late fee.

Class Fees

3/4 hr class	\$360/10 months or \$36/monthly installments
1 hr class	\$420/10 months or \$42/monthly installments
1 1/4 hr class	\$520/10 months or \$52/monthly installments
1 1/2 hr class	\$630/10 months or \$63/monthly installments
Unlimited Fee:	\$1550/10 months or \$155/monthly installments (Unlimited fee entitles the student to attend as many RIM Classes as wanted).
Competition Team:	\$2500/10 months or \$250/monthly installments

How To Pay

Payments are accepted at the Satellite Beach Recreation office by cash, check, money order or credit card. For the convenience of the credit service, the company charges a processing fee of \$1.95 or 2.5% per transaction whichever is greater. Make all checks payable to the City of Satellite Beach. You can send your payments by mail or come to the office at 1089 South Patrick Dr., Satellite Beach, 32937. Office hours are Monday through Friday, 8:30am-5pm. At this time, online registration is not available for the RIM Fall dance classes.

A drop box is located on the office window and can be used when the office is closed and the center is open. For any questions you may have regarding your payments, please call the Recreation office at 321 773-6458.

Please note: Dance instructors do not accept tuition payments.

Registration Fee

There is an annual one-time registration fee of \$20 for the 1st child registered in our Rhythm in Motion Program. Additional siblings pay \$15 each. Starting August 21st registration fees will increase to \$25/\$20. This fee will be charged and is payable at the time of registration which covers the dancer until July 2018. This fee is non-refundable if the student decides to discontinue classes.

Late Fees

Tuition payment deadlines are strictly enforced and will incur a \$8 late fee (per student, per class) automatically applied to your account after the 10th of each month. Competition and Unlimited students will pay a \$16 flat fee.

Please Note: Students whose tuition payment is late by two months will be denied entry into their RIM classes until payment is made. Re-entry into class may not be guaranteed even after payment is collected.

Discontinuing Enrollment

Before withdrawing from a class, please discuss this decision with Ms. Lanore, Rhythm in Motion Director by calling (321) 693-1943. This will give her the opportunity to rectify any concerns that may be occurring or perhaps place the student in another class that is more suitable for their needs. If you do decide to change a class or withdraw, please notify the Recreation Office.

Refunds

A full refund will be issued for any tuition already paid for future months. Tuition for the current month in which the student discontinues class, is not refundable. Please remember credits are not given due to illness or missed classes and registration fees are non-refundable.

NSF/Returned Checks

The following fees will be assessed on any NSF or Returned Check. No further registration or participation will be allowed until outstanding fees are paid in full. Please call the Recreation Office for any concerns regarding a NSF.

\$25 fee for checks up to \$50

\$30 fee for checks from \$50-\$300

\$40 or 5% fee (whichever is greater) for checks over \$300

NSF/Returned Checks to Lanore & RIM

There will be a \$20 fee on all returned checks that were payable to Lanore Hensley or Rhythm in Motion. Notification of NSF/Returned Check and collection of fees will be handled directly by Lanore Hensley.
